Requirements for vendors and units

Shall hold a valid Texas Sales and Use Tax Permit and provide permit copy

Shall have a Food Handlers Permit and provide certificate copy

Shall hold a current year City of Poth Food Service License

Vendors are prohibited from operating on public streets (Special event exception approved by City)

Shall keep the grounds around their mobile unit space free of litter, trash and paper waste at all times

Shall provide waste container for customers at such times when unit is in operation

Shall be readily identifiable by business name, permanently affixed, and prominently displayed upon at least 2 sides of the unit.

Shall maintain a current state motor vehicle inspection sticker and a current state motor vehicle license plate registration sticker.

Shall only be located on property zoned for Mobile Food Vending Court or Accessory Mobile Food Vending as set forth in the Zoning Ordinance or locations approved for special events approved by City.

Shall be readily movable (capable of moving immediately upon the request of the mayor or his/her designee)

Shall comply with any reasonable request from the City personnel to cease operations and/or to temporarily reposition their mobile unit for maintenance crews to conduct repairs or other related maintenance functions

Shall post permit in or on the unit in a conspicuous place

Shall submit proof of rental/lease agreement if located on private property

Shall observe all parking rules
